CRIMINAL CASES OF HIGH PUBLIC INTEREST THAT GIVE RISE TO A RISK OF THE PRESENCE OF A POLITICAL DIMENSION

* When assessing the existence of a political component, GYLA is guided by: the 2012 Resolution 1900 of the Parliamentary Assembly of the Council of Europe; the European Convention on Human Rights and the case law of the European Court of Human Rights (on Article 18); the interpretative documents of the OSCE Parliamentary Assembly; the practice of the UN Working Group on Arbitrary Detention (WGAD); and documents related to these sources.¹

* Regarding the individuals (1-69) listed in the table, the GYLA has assessed that **the observation of criminal cases reveals that the use of criminal prosecution mechanisms against activists, which is aimed not only at identifying and preventing specific possible crimes, but also at suppressing the right to freedom of assembly and expression, is not an isolated violation of rights, but also contains an element of political motive/hidden intent.**² Regarding other cases, the organization continues to monitor for further assessment.
