Through these activities, the organization continued to document human rights conditions, inform the public and international mechanisms, and monitor justice processes.

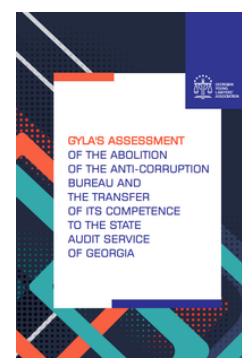
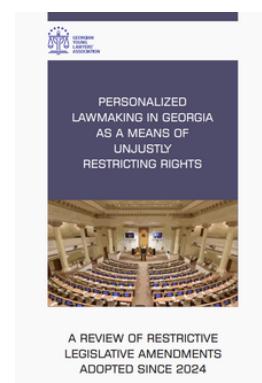

Legal Assistance and Consultation During the Reporting Period

1 April - 31 July, 2026

Despite the crisis and limited resources, providing free legal assistance remains one of the core directions of GYLA's work. The organization continues to conduct strategic litigation at local and international levels, which is particularly crucial in conditions of daily human rights violations.

Three new cases were submitted to the Strasbourg Court: The criminal case of Mzia Amaglobeli, The case regarding systemic torture, The case concerning the arrest of an individual for standing on a sidewalk

A response statement was submitted to the Strasbourg Court **regarding the 2024 parliamentary elections.**

Two new cases were submitted to the Constitutional Court: The case concerning the voting rights of emigrants, The case regarding protracted court proceedings in a civil case involving children's rights.

An **Amicus Curiae brief** was submitted to the Constitutional Court regarding the lawsuit demanding the ban of four political parties.

GYLA is litigating six new / ongoing criminal cases, including a case regarding the potential use of an **experimental weapon involving chemical substances mixed into water cannons** against demonstrators.

The organization provided **over 50 consultations** on various legal matters.

GYLA continued working on ongoing cases that were not finalized during the reporting period.

GYLA's International Advocacy Activities During the Reporting Period

1 April - 31 July, 2026

International Advocacy

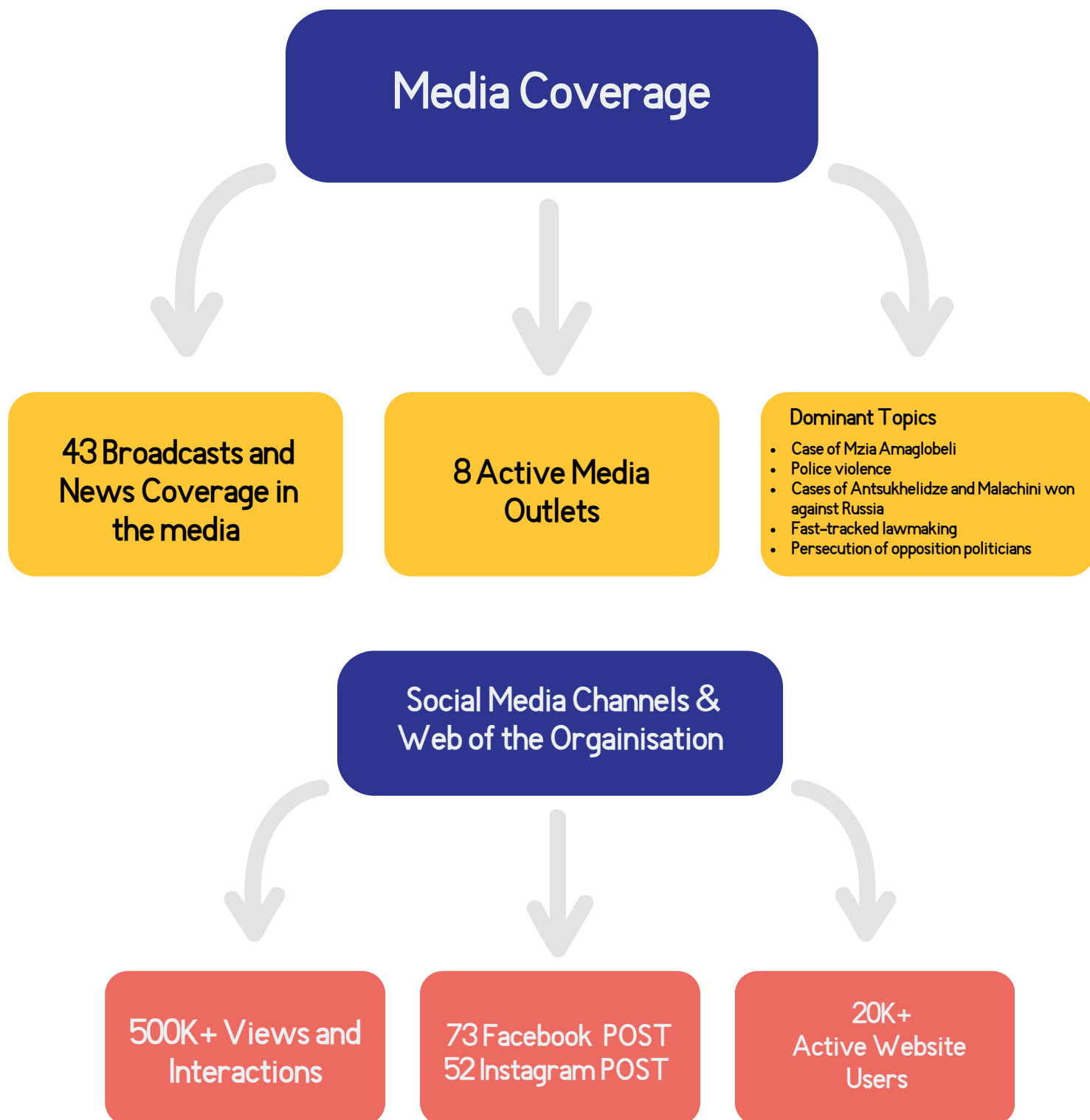
We submitted assessments to the Committee of Ministers of the Council of Europe:

- **Requesting** the creation of a collective execution mechanism for compensation assigned to the Russian Federation regarding the 2008 war cases.
- **Submitted** 3 reports regarding the execution of cases involving various groups subject to enhanced supervision with respect to Georgia.

GYLA's Successes

- GYLA won cases against the Russian Federation at the Strasbourg Court on behalf of **Giorgi Antsukhelidze and other Georgian military officers**.
- GYLA won a case at the Strasbourg Court concerning the detention of a person for **setting a tent**.
- The Strasbourg Court began the examination of the case regarding the so-called FARA ("Foreign Agents Registration Act"); **The Council of Europe Commissioner for Human Rights** intervened in the case as a third party.
- The Strasbourg Court **registered** two new applications from Mzia Amaglobeli.
- The "Gavrilov's Night" case won in the Grand Chamber of the Strasbourg Court was reflected in REDRESS's global **casebook**.
- Reports from the Office of the High Commissioner for Human Rights (OHCHR) **repeatedly cite GYLA's communications and publications**, highlighting the importance of the organization's objective and credible documentation of human rights.
- The court **ruled** a labor rights violation in favor of an employee dismissed from the National Center for Public Health on 1 January 2025, ordering the employer to pay compensation for forced missed work.
